strategy, veering away from Steward's more 'settlement-natural environmental' focus to his own more 'settlement social organizational' focus.

Along with a few other observations of this nature, Willey provides further clarification of the context of the development of Americanist settlement pattern archaeology through the Viru project. The remainder of the volume is one which focuses up the results of settlement archaeology projects in recent times, and will be of course of interest to students of more recent theoretical advances. Willey's commentary helps us to understand a bit more of the original formulation and rationale of the project.
